





Adolescent

ur Adolescent Outpatient Program provides specialized treatment for adolescents and families of youth age 12 to 18 struggling with substance use and related issues. Our services incorporate proven methods and personalized treatment to help adolescents develop the skills they need to live a life free of alcohol. tobacco and other drugs. In 2015, Adapt provided outpatient treatment to **192** adolescents in Douglas, Coos, Curry and Josephine counties.

INTEGRATED behavioral health

■ ntegrating behavioral health within primary care offers an opportunity for early screening and coordination of care for patients with complex health needs. Licensed Behavioral Health Consultants are positioned in primary care clinics to support treatment for patients with addictions and/or behavioral health

concerns that contribute to poor health. In 2015, Behavioral Health Consultants provided integrated care for patients at SouthRiver Community Health Center, North Bend Medical Center, Umpqua **Regional Medical Center and Evergreen** Family Medicine.

Corrections

dapt works in collaboration with Douglas County Community Corrections to provide a full range of outpatient, residential and aftercare treatment services to break the cycle of substance use, crime, and incarceration. Our work with Douglas County's Drug Court provides cost-effective drug rehabilitation and education to address underlying substance abuse issues that contribute to criminal activity. In 2015, our **Corrections Treatment** Program provided treatment to 371 individuals.

The Crossroads

The Crossroads is a 30-bed residential treatment center for men and women with substance use and co-occurring mental health disorders. Treatment is tailored to individual needs and utilizes an integrated approach that includes primary medical care, mental health services and specialized treatment programs for detoxification, chronic pain management and nicotine dependence. Crossroads also offers residential treatment for women with young children age 0 to 6. In 2015, our highly skilled residential treatment team provided services to 171 men and women.

eer Creek provides substance abuse treatment for adolescents age 13 to 17 in a structured residential environment. Personalized treatment focuses on recovery, educational achievement, therapeutic recreation, cultural development and personal skill-building. We offer a certified academic program on campus so residents don't fall behind in school while receiving care. In 2015, Deer Creek provided services to **43** adolescents, with an average length of stay of five months.



THE CROSSROADS ADULT RESIDENTIAL CARE

Healthy, Safe and Supportive

The lack of a safe, alcohol and drug free living environment can be a barrier to recovery for individuals who are transitioning out of an addictions treatment program. Transitional housing provides an opportunity for people in recovery to transition back into daily life at a slow and gradual pace.

In 2015, Adapt combined a 300K Meyer Memorial Trust award, a 100K private donation and a 300K Adapt investment to establish safe and sober transitional housing

for parents in recovery and their children. The housing program works in coordination with Kids in Common, a community collaboration designed to keep more children out of the welfare system and reunite children safely with their families as soon as possible.

We are grateful for the support we received from our community, and pleased to have an opportunity to offer healthy, safe and supportive housing to help restore individual lives and families.

Prevention

- Awarded 10K grant from Oregon Health Authority to increase awareness and understanding of problem gambling.
- Organized The Blast Run/Walk for Prevention & Recovery, with 329 participants from throughout Oregon.

- Partnered with Douglas Public Health Network to manage Tobacco Prevention & Education Program and Healthy Communities grants.
- Provided Mentoring and Positive Youth Development programs to nearly 200 students at schools throughout Douglas County.
- Partnered with CHI Mercy Foundation on the Youth Media Project, Life Skills Training and Up2UsNow Child Abuse Prevention Project.
- Provided and organized community trainings on several topics, including suicide prevention, sexual abuse prevention, and developmental assets.

Treatment

- Provided primary care, behavioral healthcare and addictions treatment for 5,262 individuals in Douglas, Coos, Curry and Josephine counties, an increase of 669 or 14.5% over the previous year.
- Awarded an additional 244K annually from the Health Resources & Services Administration to expand services at SouthRiver for patients with behavioral health and substance use disorders, including medication-assisted treatment for prescription opioid and heroin addiction.
- Received Oregon Health Authority certification to provide mental health services, laying the groundwork to expand access to mental healthcare in 2016.

- Began work to expand medication-assisted addiction treatment and medical detox at the Crossroads residential care.
- Awarded Mercy Community Benefit grant to provide nicotine replacement therapy for patients in residential care.
- Received seven Community Incentive awards from the Umpqua Health Alliance for meeting 10 out of 11 healthcare quality metrics.
- Awarded 18K to participate in the Oregon Health Authority Council of Clinical Innovators.
- Behavioral Health Consultants provided counseling and addiction treatment to patients at SouthRiver Community Health Center, Umpqua Regional Medical Center, North Bend Medical Center and Evergreen Family Medicine.
- Awarded Umpqua Health Alliance Community Incentive grant to establish Tobacco & Nicotine Recovery Program.
- Received a Justice Reinvestment grant to increase the availability of Residential Substance Abuse Treatment, and piloted Residential Substance Abuse Treatment aftercare for Drug Court participants.
- Provided school-based behavioral health and addiction counseling in Douglas, Coos and Josephine counties.

hanges in Oregon's healthcare landscape made 2015 an exciting and busy year at SouthRiver Community Health Center. Oregon's triple aim to improve health outcomes, improve access to care and lower healthcare costs supports the mission of SouthRiver to provide timely and affordable access to the highest quality care for all patients, regardless of ability to pay. In 2015, SouthRiver provided 12,986 clinical service visits to 2,851 patients, an increase of 183 patients over the previous year.

year focused on enhancing our clinical capacity and the menu of services available to meet the healthcare needs of our growing patient population. The addition of new clinical staff has led to improvements in patient care coordination, and has allowed us to enhance care for patients with complex and co-occurring health conditions. With help from the U.S. Health Resources and Services Administration, SouthRiver is taking steps to build an integrated care team to increase access to treatment for behavioral health and substance use conditions that may contribute to poor physical health.

In 2015, Community Incentive Program funding from the Umpqua Health Alliance allowed us to focus attention on meeting key health quality benchmarks for adolescent well-care, colorectal cancer screening, depression screening, women's health, preventive oral health screening, as well as quality improvement in patient care and health outcomes. SouthRiver's commitment to patient-centered care means higher-quality care, lower costs and improved healthcare experiences for our patients and providers.

We are deeply grateful for the continued support of our board members, clinical and support staff, and our many community and healthcare partners. As we look forward to 2016, SouthRiver will continue to serve our community by providing comprehensive, high-value care for our patients.
